Our 5G C-Band Interference Filters are designed for use in both single and multi-feed receive antenna applications. The units are easily installed between the C-Band feedhorn and the LNA or LNB. These 5G C-Band filters offer increased suppression below 3980 MHz for cellular frequencies, including 5G, commercial and military navigational communications (radar), as well as coastal / marine vessels operating below the 5G C-Band. With filtering performed at the 5G C-Band frequencies, the overall picture quality is improved, as the filter prevents overload of the LNA and LNB.


